In consideration of the activities, as well as for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the undersigned does hereby waive all rights against Canoe Outpost, and does hereby release, agree to defend, indemnify and save Canoe Outpost harmless from any and all claims of every kind resulting in loss of life, personal or bodily injury or property damage, including claims alleged to have arisen from any negligence by Canoe Outpost, by reason of participation in any activities available at Canoe Outpost. The signing of this form shall be binding on the undersigned as well as the heirs, executors and administrators of the undersigned and it shall inure to the benefit of the directors, officers, employees, agents and contractors of Canoe Outpost. The undersigned hereby agrees that equipment rented from Canoe Outpost is rented "AS IS". In addition to the rental amount, the undersigned hereby agrees to pay for any damage to the equipment or for damage the undersigned causes to the property of others. In the event the undersigned fails to return any rental equipment Canoe Outpost shall be reimbursed by a sum equal to the replacement value of such equipment plus the reasonable costs incurred by Canoe Outpost in attempting to search for such equipment. Adult persons 18 years of age or older must sign this form on their behalf. Any Adult who signs this form on behalf of any Minor shall conclusively be presumed to be the parent, guardian or a person who has the duty, right and power to exercise control, discipline and supervision over such persons as well as the authority to consent to allow such persons to participate in the activities at Canoe Outpost; such Adult shall have absolute legal responsibility for such Minors.
